To date, we have received pledges of \$473,889.00. We have sent \$115,000.00 to Thrivent to reduce our principal loan balance. We currently have \$61,371.46 in the dedicated account for further debt reduction.

Total

We are making a \$5,000 payment the first of each month to pay down debt as long as we keep receiving the Vision 2020 contributions. During theyear, we received one payment from a member who requested that 100% go to debt reduction.

We have received 43.08% of our total pledges as of 12/31/2020 and have two years left in the Vision 2020 Capital Campaign.
